

A FEW WORDS FROM THE PRESIDENT



Dear Colleagues,

Each period has its own character, which makes it remarkable for future historians. Our days are dominated by the return of infectious diseases, which were known only as phenomena of the past and as historical objects of research. Now we are in a situation where we get the feeling of becoming part of medical history more than some generations before us. On the one hand, we are witnessing a pandemic with a tremendous impact on public health, society, and the economy; on the other hand, we are experiencing incredible and unprecedented advances in vaccine development. It is possible that future research will assess the value of pharmacy and drug development as an achievement of historic dimensions.

Being part of these developments also brings with it the responsibility to preserve materials, publications, communications as objects of study for our colleagues in the future. This is all the more important because electronic publications, e-mails, etc. are much less durable than documents on papyrus or paper. So we should actively try to preserve documents and objects of the present time for future generations.

In this sense, our American colleagues have started a remarkable project to collect material documenting how the pandemic affected our lives, especially pharmacy and medicine. Some inconveniences we currently suffer from will disappear, but some will remain, probably including the practice of online conferencing. Although some say these have led to a plague of its own right ("zoom fatigue") and many of us find it boring to follow such conferences all day, they are a wonderful opportunity to bring people with common interests together very easily.

In our field, there have been very successful examples, such as the Pharmaceutical History Festival organized by the American Society last fall, which turned out to be a tremendous success really fulfilling what the title had promised. The British Society was able to interest almost 200 participants from all over the world for an evening lecture at the end of February. More events will follow, please check our website or those of the national societies.

Of course, the International Society does not want to be left behind, and will therefore hold a virtual conference at the end of April (see announcement in this newsletter and online). Embedded in the two-day conference will be the legally required meetings of the boards and the general assembly. Despite some great experiences with online presentations and discussions, I'm sure everyone will be glad when we can meet again in person. In this respect, we very much hope for the next international congress, which is now planned for September 2022 in Milan. Hopefully, we will then be able to take a first look back at a pandemic that has been overcome.

QUELQUES MOTS DU PRÉSIDENT

Mesdames et Messieurs,

Chaque période a ses propres particularités, qui la rendent unique pour les futurs historiens. Nos jours sont dominés par le retour de maladies infectieuses qui n'étaient connues que comme des phénomènes du passé et comme des objets de recherche historiques. Nous nous trouvons maintenant dans une situation où nous avons le sentiment de faire partie de l'histoire médicale plus que certaines générations avant nous. D'une part, nous assistons à une pandémie dont l'impact sur la santé publique, la société et l'économie est sans précédent ; d'autre part, nous sommes témoins de progrès incroyables et inouïs dans le développement des vaccins. Il est possible que à l'avenir les historiens évaluent le développement de la pharmacie et des médicaments comme une réalisation de dimension historique.

Ce qui implique qu'il est également de notre responsabilité de préserver les matériaux, les publications, les communications comme objets d'étude pour nos futurs collègues. Cela est d'autant plus important que les publications électroniques, les courriers électroniques, etc. sont beaucoup moins durables que les documents sur papier ou sur papyrus. Nous devrions donc nous efforcer activement de préserver les documents et les objets du temps présent pour les générations futures.



À cette fin, nos collègues américains se sont lancés dans un remarquable projet de collecte de matériel documentant la manière dont la pandémie a affecté nos vies, en particulier la pharmacie et la médecine. Certains des inconvénients dont nous souffrons actuellement disparaîtront, mais d'autres subsisteront, notamment probablement la pratique des conférences en ligne. Bien que certains disent que ces conférences ont provoqué un fléau ("fatigue du zoom") et que beaucoup d'entre nous trouvent ennuyeux de suivre de telles conférences toute la journée, elles sont une extraordinaire occasion de rassembler très facilement des personnes ayant des intérêts communs.

Dans notre domaine, il y eut des exemples très réussis, comme le Festival d'histoire de la pharmacie organisé par la Société américaine l'automne dernier, qui a été à la hauteur de son nom. La Société britannique a pu attirer près de 200 participants du monde entier pour une conférence en soirée à la fin du mois de février. D'autres événements suivront, veuillez consulter notre site web ou ceux des sociétés nationales.

Bien entendu, la Société internationale ne veut pas être en reste, c'est pourquoi elle organisera une conférence virtuelle à la fin du mois d'avril (voir l'annonce dans ce bulletin et en ligne). La conférence de deux jours comprendra les réunions des conseils d'administration et de l'assemblée générale prévues par la loi. Malgré les excellentes expériences de présentations et de discussions en ligne, je suis convaincu que chacun sera heureux de se retrouver « en présentiel ». À cet égard, nous attendons avec joie le prochain Congrès international, désormais prévu pour septembre 2022 à Milan. Nous espérons que nous pourrons alors jeter un premier regard sur une pandémie alors surmontée.

EINIGE WORTE DES PRÄSIDENTEN



Liebe Kolleginnen und Kollegen,

Jede Zeit hat ihren eigenen Charakter, die sie für zukünftige Historiker bemerkenswert macht. Unsere Tage sind von der Rückkehr von Infektionskrankheiten bestimmt, die man nur als Phänomene der Vergangenheit und als historische Forschungsobjekte kannte. Jetzt befinden wir uns in einer Situation, in der wir das Gefühl bekommen, mehr als einige Generationen vor uns Teil der Medizingeschichte zu werden. Einerseits sind wir Zeugen einer Pandemie mit ersthaften Auswirkungen auf das öffentliche Gesundheitswesen, die Gesellschaft und die Wirtschaft, andererseits erleben wir unglaubliche und bisher nie gekannte Fortschritte in der Entwicklung von Impfstoffen. Möglicherweise wird die zukünftige Forschung den Wert der Pharmazie und der Arzneimittelentwicklung als eine Errungenschaft von historischer Dimension bewerten.

Teil dieser Entwicklungen zu sein, bringt auch die Verantwortung dafür mit sich, Materialien, Publikationen, Kommunikation als Untersuchungsobjekte für unsere Kollegen in der Zukunft zu bewahren. Das ist umso wichtiger, als elektronische Publikationen, E-mails etc. wesentlich weniger dauerhaft sind als Dokumente auf Papyrus oder Papier. Wir sollten also aktiv versuchen, Dokumente und Objekte der Jetztzeit für zukünftige Generationen zu sichern.

Dazu haben unsere amerikanischen Kollegen ein bemerkenswertes Projekt gestartet, um Material zu sammeln, das dokumentiert, wie die Pandemie unser Leben, insbesondere Pharmazie und Medizin beeinflusst. Einige Unannehmlichkeiten, unter denen wir gegenwärtig leiden, werden wieder verschwinden, aber manches wird bestehen bleiben, wahrscheinlich auch die Praxis der Online-Konferenzen. Obwohl manche sagen, diese führten zu einer Seuche für sich („Zoom-Fatigue“) und es viele von uns langweilig finden, den ganzen Tag solchen Konferenzen zu folgen sind sie eine wunderbare Gelegenheit, Menschen mit gemeinsamen Interessen sehr einfach zusammenzuführen.

Auf unserem Gebiet gab es sehr gelungene Beispiele, so das pharmaziehistorische Festival, das die amerikanische Gesellschaft letzten Herbst organisierte und das seinem Namen alle Ehre machte. Die britische Gesellschaft konnte Ende Februar fast 200 Teilnehmer aus der ganzen Welt für einen Abendvortrag interessieren. Weitere Anlässe werden folgen, bitte schauen sie auf unsere Webseite oder diejenige der nationalen Gesellschaften.

Natürlich möchte auch die Internationale Gesellschaft nicht zurückstehen, und wird daher Ende April eine virtuelle Konferenz abhalten (siehe Ankündigung in diesem Newsletter und online). In die zweitägige Konferenz eingebettet sind die rechtlich erforderlichen Sitzungen der Vorstände und die Mitgliederversammlung. Trotz der teilweise großartigen Erfahrungen mit Online-Vorträgen und Diskussionen, bin ich sicher, dass alle froh sind, wenn wir uns wieder persönlich treffen können. Wir hoffen insofern sehr auf den nächsten internationalen Kongress, der jetzt für September 2022 in Mailand geplant ist. Hoffentlich können wir dann einen ersten Rückblick auf eine überwundene Pandemie werfen.

ISHP RESEARCH GRANT

The ISHP will continue to support pharmaceutical history research proposals of international relevance and will welcome proposals for 2022. The grant is primarily, but not exclusively, intended for academic projects. Proposals for the 2022 ISHP Fellowship grant must be sent by email, in English language to the ISHP General Secretary by **August 31, 2021**.

The proposal must include:

- a detailed description of the research project which is usually but not necessarily done at an academic institution,
- a detailed discussion of the project's relevance in terms of internationality,
- a curriculum vitae of the applicant,
- a confirmation that the applicant is a member of ISHP issued by his national organization,
- a list of former research projects and publications of the applicant,
- a letter of recommendation from a senior academic teacher,
- a detailed list of expenses expected (i.e., costs for traveling, obtaining literature).

The International Society for the History of Pharmacy is again awarding a research grant for 2500 Euro in total.

The proposals will be judged by a fellowship committee comprised of the ISHP President, the ISHP General Secretary and three distinguished scientists in the field of pharmaceutical history, nominated by the Select Executive Committee.

A successful applicant is obliged to describe the project during the ISHP General Assembly or another opportunity during the International Congress for the History of Pharmacy held in the year 2021. After the project has been completed, ISHP needs to be informed in detail about the results (e.g., a comprehensive report, reprints of publications) until the project is completed, and interim reports have to be sent to ISHP every year in December.

OBITUARY: GRAZIELLA L. NARCISA BAICU (1922-2020)

An important loss for the Romanian Society for the History of Pharmacy and also for the Romanian Academy was the death of Doctor Pharmacist Graziella Lygia Narcisa Baicu (1922-2020), who died on April 15, 2020, due to cardiac disease. Graduate of the Faculty of Letters (1947) and of the Faculty of Pharmacy in Bucharest (1948), Ph.D. in pharmaceutical sciences (1975), full member of the International Academy of History of Pharmacy (Seville, September 15, 1974), she had a rich professional, scientific, editorial activity within the Institute for State Control of Medicines and Pharmaceutical Research (ISCMPPR), the Society of Medical Sciences, the Department of Pharmacy, and the Medical Publishing House.

From March 1, 1949, as the editorial secretary, she ensured the publication of the journal *Farmacia*, an organ of the General College of Pharmacists. She was active for only two months, the publication being abolished due to the liquidation of the College, his tutelary institution, as a result of the nationalization that took place on April 2, 1949.

She had the initiative to create an orientative publication, entitled *Centrofarm Newsletter*, ensuring, in addition to content programming, all printing operations. The journal appeared in ten issues (August 1949-December 1950) and inserted in its pages, provisions, instructions, legislative texts, etc., concerning legal, technical, organizational, and methodological regulations, based on which the new pharmaceutical sector, restructured according to the criteria socialist economy and centralized planning, to be oriented and guided. Other functions performed: editorial secretary at the journal *Farmacia* (March 1, 1953-September 1958); director of three successive Medical Agendas 1955, 1956, 1957, coordinated by DGF from the Ministry of Health; 1973-1988 contributed to the publication of the journal *Pharmacovigilance*, 64 quarterly publications.

Adriana – Elena Tăerel, President of RSHP and Pharmacist Maria-Gabriela Suliman, President of the Bucharest Section of RSHP, handed over to Dr. Ist. Pharm. Graziella-Lygia-Narcisa Baicu Medal "Prof. Dr. Pharmacist Alexandru Ionescu-Matiu", for the entire activity as a scientific researcher in the field of the History of Pharmacy.

OBITUARY: SLAVA PRIKHODKO (1938-2020)

It is with much regret to inform members of the ISHP of the passing of Pharmacist Slava Prikhodko in 2020.

Graduated from the Faculty of Pharmacy of the Kaunas Medical Institute (Lithuania) in 1967, she directed a pharmacy in one of the ancient Belarusian city of Rogachev for 14 years between 1982 and 1996.

Having a 53-year of professional experience in the field of pharmacy, Slava Prikhodko was also a respected scholar of the history of pharmacy, instilled a love for the profession in many specialists, including the young head of her pharmacy with whom she organized a historical exposition in the pharmacy, which now has more than 300 items. In 2012, they published a book entitled *A Historical Sketch of the Rogachev Region and the Pharmacy Network of the Rogachev Region*.

Pharmacist Slava Prikhodko enjoyed great prestige among colleagues, the population, and the city authorities. We would like to extend our condolences to her family, friends, and colleagues.

OBITUARY: FRANZ WINKLER (1929-2020)

On September 7, 2020, Franz Winkler died at the age of 92. Winkler came from a long-established Innsbruck pharmacist family, so his choice of profession, he studied pharmacy, also connected his special interest in the history of pharmacy. After the war, the private pharmaceutical historical collection stored during these years, which went back to his grandfather Ludwig Winkler, was restored and re-erected on Franz Winkler's initiative.

From 1965 to 1999 Franz Winkler was President of the Austrian Society for the History of Pharmacy, at the same time Vice-President of the International Society for the History of Pharmacy for a number of years, and since 1977 a member of the Académie internationale d'histoire de la pharmacie. In 1961 and 1977 he organized the International Congress for the History of Pharmacy in Innsbruck for the ISHP.

In addition to this commitment to the history of pharmacy and the corresponding companies, Franz Winkler was drawn into professional politics very early on, so from 1962 to 1964, he held the position of regional branch manager of the Chamber of Pharmacists in Tyrol. From 1964 Vice-President of the Austrian Chamber of Pharmacists in Vienna, then also chairman of the Pharmacists' Association, representing the interests of the self-employed pharmacists, Franz Winkler was elected President of the Austrian Chamber of Pharmacists in 1980, which he held for 16 years until 1996. After a long and extremely active life, Franz Winkler fell asleep peacefully on September 7, 2020, following a short illness.



A virtual tour of the historical exposition was organized in an old state pharmacy in Postavy, in the Vitebsk region. The building of the pharmacy is an architectural monument.

- The holding of the historical forum in the museum of the Belarusian Polesye, dedicated to the 460th anniversary of the opening of the first pharmacy in Belarus (Pinsk).
- Joint research work with the staff of the state museum in Ruzhany about the healers and pharmacists of the magnates Sapiega (XVII-XIXth centuries).
- Preparation and publication of scientific articles on historical topics in journals.

BENELUX - KRING VOOR DE GESCHIEDENIS VAN DE PHARMACIE IN BENELUX / CERCLE BENELUX D'HISTOIRE DE LA PHARMACIE / CIRCLE FOR THE HISTORY OF PHARMACY IN BENELUX

The Circle has been less active than previous years, due to the COVID-19 pandemic. Our planned conference in Bussum on May 16-17, 2020, had to be postponed to 2022. As a result, the annual consultation of our members could not take place as well.

The Circle published two bulletins in 2020. Issue 135 contained an article by Marie-Christine De Smet about de apothecary shop of the Vande Vyvere Family in Bruges, following her talk on the subject at our conference in Bruges in 2019. The issue also contained two reprints from *Jaarboek Amstelodamum*, issue no. 106. One was about a “yawner” (gaper) wearing a uniform in Amsterdam. Yawners are typical Dutch wooden busts that were used to indicate the presence of apothecary shops in the past. The other reprint was about the seventeenth-century apothecary Abraham Francen (of whom Rembrandt made an etching) by Monique A.F. Peters. Issue 136 contained an article by Jan Trooster about the Jewish female apothecary Branco van Thijn, who worked in Auschwitz and died in Ravensbrück, to commemorate the end of the Second World War 75 years ago. The issue further contained articles by Nanno Bolt about apothecary guilds in the lands of the Dukes of Burgundy, and by Guy Gilias about the “Office of Beneficence”, a welfare organization in Louvain that founded the Central Apothecary, which provided medicines for the urban poor between 1882 and 1925.

The Circle was shocked to hear about the passing of our former board member Sjoerd Wicherink and board member Harm Beukers. The Circle published several digital newsletters for its members in 2020, with interesting publications and activities about the history of pharmacy. Throughout the pandemic, our website, www.kringbenelux.eu, has been another consistent medium. Despite the measures to contain COVID-19 in the Netherlands and Belgium, and despite the uncertain prospects of gathering our members in the new year, the Circle intends to celebrate its 70th anniversary in 2021. Around World Pharmacists Day (September 25) and the name day of Saints Cosmas and Damianus (September 26), we intend to publish a special bulletin issue. In this way, the Circle hopes to contribute to more awareness and research in the history of pharmacy.

CZECHIA – THE SECTION OF HISTORY OF PHARMACY OF THE CZECH PHARMACEUTICAL SOCIETY

For instance, the Faculty of Science of Charles University, which had been involved also in the education of pharmacists until the establishment of faculties of pharmacy in Czechoslovakia in 1952, celebrated its centennial in 2020. That is why two articles focused on the history of pharmacy education provided by the Faculty of Science of Charles University were published. 
Our members were also involved in a project conducted by the Czech Pharmaceutical Museum, an institution intensively collaborating with our society. Within this project, a handwritten recipe book of a Prague monastic pharmacist from the 18th century had been restored and digitized. We hope the situation will get better in 2021. If possible, we are prepared to organize the traditional symposia on the history of pharmacy and participate in other related events, including virtual ones.

Moreover, the Czech Pharmaceutical Society, i.e., the parent society of the Section of History of Pharmacy, is celebrating its 150th anniversary in 2021. There will be a special meeting on this important occasion, either real, virtual, or combined, depending on the epidemic situation. As part of HCØ 2020, Poul R. Kruse gave a lecture “H.C. Ørsted og farmacihistorien” (H.C. Ørsted and the history of pharmacy).



FRANCE – SOCIÉTÉ D'HISTOIRE DE LA PHARMACIE



Like all societies and associations, the French Society for the History of Pharmacy (SHP) experienced a very special year in 2020, marked by the health crisis which prevented us from meeting according to the usual schedule. But the two communication organs of the SHP: the *Revue d'Histoire de la Pharmacie* and the website www.shp-asso.org were both dynamic. Our site has been publishing an exhibition for more than 10 years (142nd exhibition in progress), the last ones have been on "the entertaining journals for doctors, financed by the pharmaceutical industry in the 20th century" and on "the healer kings". As for the *Revue*, it is still accessible on the Internet on the Persée database, until the year 2014 (only the summaries are accessible between 2015 and 2017). In the year 2020, our *Revue* has published 23 studies and will have a total volume of 552 pages.

As every year, the SHP with the Maurice Bouvet-Henri Bonnemain Family has endowed a prize awarded by the French National Academy of Pharmacy. A prize awarded this year to Aurélien Berdot for his thesis entitled "100 years of history of pharmacy practice told through a prescription book dating from 1918". It is through the information contained in this century-old register, and in particular thanks to the details of all the formulas of the magistral preparations issued between 20 August 1918 and 14 January 1919, that we can observe the type of active ingredients used, their natural or synthetic origin, the galenic forms in vogue, the variety of their indications and therefore also see the pathologies affecting the French population at that time appearing in the background.

Moreover, despite the health crisis, we held three sessions (sometimes in the form of videoconferences) which enabled us to hear 16 oral communications on very diverse subjects. A day in Paris on 28 October 2020 was the occasion to evoke the bicentenary of the discovery of quinine in 1820 by two Parisian pharmacists, Joseph Pelletier and Joseph-Bienaimé Caventou. This session provided an opportunity to explore different aspects of the history of cinchona and quinine. In addition, several members of the SHP participated in lectures on the history of pharmacy in France during this period.




Quinine was first extracted, isolated, purified, and named by French pharmacists and chemists Joseph Pelletier and Joseph-Bienaimé Caventou in 1820.

In 2021, we will continue to actively promote the history of pharmacy. This is also the fifth year of the University Diploma in the History of Pharmacy at the University of Paris, with the very active involvement of SHP members. Visits and case studies are also planned. Like every year, teaching will be provided by members of the SHP. We are also taking part in a course for pharmacy students in Lyon, and a course for the general public in Paris.

Comme toutes les sociétés savantes, la Société d'Histoire de la Pharmacie (SHP) a vécu une année 2020 très particulière placée sous le signe de la crise sanitaire qui nous a empêché de nous réunir selon le calendrier habituel. Mais les deux organes de communication de la SHP : la « Revue d'Histoire de la Pharmacie » et le site Internet www.shp-asso.org ont, tous les deux, été dynamiques. Notre site publie tous les mois depuis plus de 10 ans une exposition temporaire (142ème exposition en cours), les dernières ayant porté sur « les journaux divertissants pour les médecins, financés par l'industrie pharmaceutique au XXe siècle » et sur « les rois guérisseurs ». En ce qui concerne la Revue, elle est toujours accessible sur Internet sur la base de données Persée, jusqu'à l'année 2014 (seuls les sommaires sont accessibles entre 2015 et 2017). Au cours de l'année 2020, notre Revue a fait paraître 23 études et aura un volume global de 552 pages.

Comme chaque année, la SHP avec la famille Maurice Bouvet-Henri Bonnemain a doté un prix remis par l'Académie Nationale de Pharmacie, prix décerné cette année à Aurélien Berdot, pour sa thèse intitulée « 100 ans d'histoire de la pratique officinale racontés au travers d'un ordonnancier datant de 1918 ». C'est au travers des informations contenues dans ce registre centenaire, et notamment grâce aux détails de toutes les formules des préparations magistrales délivrées entre le 20 août 1918 et le 14 janvier 1919 que l'on peut observer le type de principe actif utilisé, leur origine naturelle ou synthétique, les formes galéniques en vogue, la variété de leurs indications et donc voir apparaître également en filigrane les pathologies touchant la population française à cette époque.

Par ailleurs, malgré la crise sanitaire, nous avons tenu 3 séances (parfois sous forme de visioconférences) qui ont permis d'entendre 16 communications orales sur des sujets très divers. Une journée à Paris le 28 octobre 2020 a été l'occasion d'évoquer le bicentenaire de la découverte de la Quinine en 1820 par deux pharmaciens parisiens, Joseph Pelletier et Joseph-Bienaimé Caventou. Cette séance a permis d'explorer différents aspects de l'histoire du quinquina et de la quinine. Plusieurs membres de la SHP ont participé à des enseignements d'histoire de la pharmacie en France pendant cette période.



En 2021, nous continuerons à promouvoir activement l'histoire de la pharmacie. C'est aussi la cinquième année du Diplôme Universitaire d'histoire de la pharmacie à l'Université de Paris, avec l'implication très active de membres de la SHP. Des visites et des études de cas sont également prévues. Comme chaque année, l'enseignement sera assuré par des membres de la SHP. Nous participons également à un cours pour les étudiants en pharmacie à Lyon, et un cours destiné au grand public à Paris.

FRANCE – SAUVEGARDE DU PATRIMOINE PHARMACEUTIQUE

Like many other associations, the Covid-19 pandemic interrupted normal relations between members and the association's leaders. Yet we tried as much as possible to maintain the link between us.

The beginning of the year was very painful because we lost Mrs. Dominique Kassel, a friend and a pillar of the Sauvegarde du Patrimoine Pharmaceutique in person. She was one of the pioneers of our association and for a long time served as its Secretary General. She saw to the end to the conservation of the objects and old books of the Collections of the Order of Pharmacists, of which she drew up a detailed inventory. Many students came to consult her to find the documents necessary for their thesis, and I think that they appreciated her knowledge as well. We miss her very much and she will always be present in our hearts.

Our General Assembly for the year 2019 planned for the spring could not take place and we had to resort to a postal vote to ratify the financial accounts and the moral report of the President in December 2020.

Only one weekend was planned for the spring in the footsteps of Maria Magdalena (Patron Saint of many apothecary corporations) at the Sainte Baume in Provence. We were obliged to cancel it.

Similarly, our trip to Romania planned for October was postponed to 2021. However, we are looking forward to visiting the museums in Sibiu and Cluj, as well as the Faculty of Pharmacy in Bucharest.

During the confinement, we were able to send our members three long slideshows on French apothecaries. This is undoubtedly the most complete inventory of this heritage to date. Another slide show was devoted to the pharmaceutical objects exhibited at the National Gallery of Art in Washington, D.C.

On the other hand, the Association's collections have been enriched. We received the donation of the entire collection of glass jars from the Ravasse Pharmacy near Rouen (more than 200 jars) as well as a collection of amber glass jars from a pharmacy in Metz (about 60 jars). We have also completed our collection of pewter to add to the objects presented in our exhibition and other objects.

The immobility to which we were constrained was the trigger for an inventory of the objects owned by our association. This unfinished work today is visible to everyone from the below link:

We have thus found an object supposed to be used to make single-unit suppositories. We call for any documentation relating to this object.

We hope that the year 2021 will be more favorable to exchange with our members and that we will return to normal activity.

Comme toutes les associations, la pandémie de la Covid-19 a interrompu les relations normales entre les adhérents et les dirigeants de l'Association. Pourtant nous avons essayé autant que possible de maintenir le lien entre nous.

Le début de l'année a été très douloureux car nous avons perdu une amie et un pilier de la Sauvegarde du Patrimoine Pharmaceutique en la personne de Madame Dominique Kassel. Elle fut une des pionnières de notre association dont elle fut longtemps secrétaire générale. Elle a veillé jusqu'au bout à la conservation des objets et des livres anciens des Collections de l'Ordre des Pharmaciens dont elle a dressé un inventaire détaillé. De nombreux étudiants sont venus la consulter pour trouver les documents nécessaires à leur thèse, et je pense que eux aussi ont apprécié ses connaissances. Elle nous manque beaucoup et elle restera toujours présente dans nos cœurs.

Notre Assemblée Générale de l'année 2019 prévue au printemps n'a pu avoir lieu et nous avons été obligé de recourir à un vote par correspondance pour entériner les comptes financiers et le rapport moral du Président en décembre 2020.

Un seul week-end était prévu pour le printemps sur les traces de Marie-Madeleine (Sainte Patronne de nombreuses corporations d'apothicaires) à la Sainte Baume en Provence. Nous avons été obligés de l'annuler.

De même notre voyage en Roumanie prévu en octobre a été reporté en 2021. Nous sommes pourtant impatients de visiter les musées de Sibiu, et de Cluj, ainsi que la faculté de pharmacie de Bucarest.

Pendant le confinement, nous avons pu adresser à nos adhérents trois longs diaporamas sur les apothicaireries françaises. C'est sans doute l'inventaire le plus complet réalisé jusqu'à présent sur ce patrimoine. Un autre diaporama a été consacré aux objets pharmaceutiques exposés à la National Gallery of Art de Washington, D.C.

Par contre les collections de l'association se sont enrichies. Nous avons reçu le don de la collection entière des pots en verre de la Pharmacie Ravasse près de Rouen (plus de 200 pots) ainsi qu'une collection de pots en verre ambré provenant d'une pharmacie de Metz (environ 60 pots). GERMANY - DEUTSCHE GESELLSCHAFT FÜR GESCHICHTE DER PHARMAZIE

The past two years have been characterized by numerous pharmaceutical historical activities of the members of the DGGP in Germany and abroad as well as a wealth of publications, which testify to the fact that the history of pharmacy can look forward to a hopeful future.

Highlights of 2018 and 2019

The highlight in 2018 was the successful Biennale in Lindau from April 6 to 8, a joint event with the Swiss Society for the History of Pharmacy (SGGP e.V.). Eight historians of pharmacy or science from Germany and Switzerland gave lectures on the topic "Pharmacy - From Craft to Science". The extensive poster exhibition was enriched by several contributions from DGGP members. The congress in the then newly opened Inselhalle was supported by numerous sponsors and was very well attended.

For the first time at a biennial more than 200 participants could be welcomed. Reports on the event in Lindau appeared in both the trade and local press. The president wrote a report for the IGGP Newsletter 2018. The DGGP e.V. thanks the organizers, especially Gerhard Gensthaler (Munich), Rotraud Mörschner (Berlin), Christiane Engel (Stein) and Ursula Hirter-Trüb (Basel) for an all around successful Biennale.

Christoph Friedrich organized the pre-symposium on "Pharmacy in Hamburg" as part of the DPhG e.V. annual congress in Hamburg on October 2, 2018. A total of four presentations were given by Frederik Vongehr (Munich), Stefanie Boman-Degen (Osnabrück), Marie-Krystin Borchers (Reinbek), and Ute Jutta Götz (Herschbach).

The symposium was very well attended and experienced a high level of public awareness. The lectures were published in 2019 by Christoph Friedrich and Karoline Guba under the title "Pharmacy in Hamburg" as volume 18 of the series "Sites of Pharmaceutical Practice, Teaching and Research".

One of the regional highlights was the festive symposium on November 10, 2018, on the occasion of the 100th birthday of Rudolf Schmitz, the founder of the Institute for the History of Pharmacy in Marburg. Speakers from various disciplines spoke on the topic of "Perspectives on the History of Pharmacy." Christoph Friedrich and Ariane Löhnert (Marburg), Bettina Wahrig (Braunschweig), Gudrun Abel (Erlangen), Gerd Folkers (Zurich) and Dietrich von Engelhardt (Lübeck). The symposium was attended by about 100 participants.

The first highlight of 2019 was a joint event of the DGGP regional groups North Rhine, Rhineland-Palatinate and Westphalia-Lippe. The birthday symposium in honor of Wolf-Dieter Müller-Jahncke took place under the title "The pointed pen turns 75" on February 24 in Düsseldorf. Speakers were Frank Leimkugel (Düsseldorf), Axel Helmstädtter (Frankfurt), Peter Dilg (Regensburg), Natalia Bachour (Zürich), Heike Spies (Düsseldorf), Michael Mönnich (Karlsruhe), Christoph Friedrich (Marburg), Katharina Pfister (Heidelberg) and Lisa Garweg (Düsseldorf).

As a further highlight of 2019, the festive symposium in honor of the 70th birthday of François Ledermann followed on February 27 and 28 in Bern as a joint event of the DGGP e.V. and SGGP e.V. On the topic "Scientia non unius populi sed orbis terrarum. On Multilingualism in the History of Pharmacy", Sabine Anagnostou and Christoph Friedrich from Germany, Hubert Steinke, Sara Ruppen and Manfred Fankhauser from Switzerland, Ives Lehmann, Hélène Lehmann and Bruno Bonnemain from France, Angelo Beccarelli from Italy and Francisco Javier Puerto Sarmiento from Spain spoke. The lectures were published in 2020 under the title "Scientia non unius populi sed orbis terrarum. On multilingualism in the history of pharmacy. Le multilinguism en histoire de la pharmacie. Festschrift für / Mélanges François Ledermann" as volume 32 of the publications of the Swiss Society for the History of Pharmacy, edited by Sabine Anagnostou, Ursula Hirter-Trüb and Claudia Zerobin Kleist. A copy was sent to the members of the DGGP e.V..

On May 11, 2019, the festive colloquium in honor of Christoph Friedrich's 65th birthday took place in Marburg. The laudatory speech was delivered by Sabine Anagnostou, President of the DGGP e.V.. Lectures were given by François Ledermann (Bern), Ulrich Meyer (Greifswald) and Stefanie Boman-Degen (Osnabrück).

The regional groups Baden and Württemberg held their as always well-attended autumn meeting on October 19 and 20, 2019 in Stuttgart on the topic "Pharmacy and Literature". Speakers were Dietrich von Engelhardt (Karlsruhe), Wolf-Dieter Müller-Jahncke (Heidelberg) and Wolf Geyer (Osnabrück).

An international highlight was the International Congress on the History of Pharmacy of the ISHP, which took place under the motto "The pharmacist and quality medicines" from September 5 to 8, 2019 in Washington, D.C. An extensive poster exhibition included quite a few presentations by members of the DGGP e.V., including posters by Ilse Denninger (Karlsbad) and Florian Eidam-Weber (Frankfurt). Presentations were given by Christoph Friedrich (Marburg), Karoline Guba (Marburg), Michael Mönnich (Karlsruhe), Peter Hartwig Graepel (Gladenbach), Axel Helmstädtter (Frankfurt), Christiane Engel (Stein), Kerstin Grothusitkamp (Marburg), and Stefan Alexandru and Meral Avici, both project collaborators of Christoph Friedrich (Marburg). Kathrin Bosse-Bringewatt (Hamburg) was elected as the new treasurer of the IGGP e.V.. The awarding of the Schelenz plaque during the IGGP Congress in Washington 2019 was canceled and will be suspended until the statutes are adopted.

The next International Congress on the History of Pharmacy in Milan has been postponed to 2022 due to the COVID-19 pandemic. <https://histpharm.org/> At the annual congress of the International Pharmaceutical Federation (FIP) in Abu Dhabi (United Arab Emirates) from 22 to 26 September, Frederik Vongehr (Munich) gave a lecture on the history of pharmacy.

Christoph Friedrich (Marburg) organized the pre-symposium on "Pharmacy in Heidelberg" as part of the annual congress of the DPhG e.V., on October 2, 2019, in Heidelberg. A total of four lectures were given by Arnt Heilmann (Hirschhorn/Neckar), Albert Borchardt (Heidelberg), Wolf-Dieter Müller-Jahncke and Elisabeth Huwer (both Heidelberg). The lectures have just been published under the title "Pharmacy in Heidelberg" as volume 19 in the series "Sites of Pharmaceutical Practice, Teaching and Research" edited by Christoph Friedrich.

Numerous other well-attended and highly regarded scientific events organized by the DGGP e.V. and its regional groups were also reported in the trade press. These are available on the association's website <https://sites.google.com/site/dggphomepage/aufgeführt>.

Reports by the President on the activities of the DGGP e.V. in 2018 and 2019 have appeared in the IGGP Newsletter (see <https://histpharm.org/>).

I would like to thank all regional group leaders and members of the DGGP e.V. for their active engagement in pharmaceutical history. Their constant presence in the scientific and general public gives pharmaceutical history an intensive life not only in Germany.

Publication activity of the DGGP e.V.

Deceased members of the DGGP e.V.

HONG KONG – HONG KONG SOCIETY FOR THE HISTORY OF PHARMACY

2020 was a challenging year with the COVID-19 pandemic having a great impact on all walks of life, which pharmacists play a significant role in the prevention and treatment of patients infected with the deadly virus. The Society scaled back a couple of the projects when the government announced travel restrictions and “social distancing” guidelines. An update of the HKAPI activities are as follows:

- Election of the 2020-2022 Term of Office of the Executive Committee of the HKAPI. The president reported the 2019 activities of HKSHP in its annual general meeting held on March 16, 2020, at the premises of the Hong Kong Jockey Club to its members. The three executive committee members comprising the president (Patrick Chiu), the honorary treasurer (Benedict Chiu), and the honorary secretary (Joanne Zhang) submitted their application for re-election and were voted by all those present, 10 of the 15 members, in the meeting for another three years from 2020-2022.
- A book, *A History of Pharmacy and the Pharmaceutical Market, 1841-2020*, authored on behalf of HKSHP, was published by the Joint Publishing Ltd. of Hong Kong for distribution in May 2020.
- An original researched paper on “The challenges and opportunities for Western Pharmacy in Colonial Hong Kong, 1945-1984,” authored on behalf of HKSHP, was published by the *Pharmaceutical Historian* in the June 2020 edition.

2021's planned projects include a book on AS Watson, 1841-2021, *Globalization and Best Practice Management*, authored on behalf of the HKSHP, the Chinese language version will be published in April and the English version in July 2021. AS Watson is a global retail pharmacy and drug store chain with a strong presence in Asia and Europe under its own or joint-venture management. These include the brands of Dirk Rossmann (Germany, Poland, and Czech), Drogas (Baltic), ICI Paris, and Kruidvat (Benelux), Marionnaud (France and Europe), Savers and Superdrugs (UK), and Watsons (Russia and Turkey).

The resumption of a publication project, postponement of which was due to the COVID-19 pandemic, on “A History of Chinese Pharmacy, From Shennong to Tu Youyou, A Journey of 5,000 Years of Materia Medica” with the Fudan University School of Pharmacy in Shanghai and the Peking Union Medical College Hospital Pharmacy Department of Beijing is now scheduled in September 2021.

Back in April 2017, we have launched our Facebook page named “Képes gyógyszerészet (Pharmacy in pictures) where we post almost every day a photo of historical interest with short explanations. As of 20 February 2021, 3338 people (compared to 1383 people on 30 January 2019) followed our facebook page at <https://www.facebook.com/gyogyszeresztortenet/>. According to our experience, social media should be taken seriously regarding the history of pharmacy, too. This is a very useful tool for delivering historical information on pharmacy to the lay public and professionals and receiving sometimes really valuable feedbacks from them.

Because of the COVID-19 pandemic in 2020 we had to postpone our annual Summer Symposium on the History of Pharmacy and probably, we have to further postpone it this year, too.

As usual, we continued the develop our website (www.gyogyszeresztortenet.hu) with some of the contents available in English. In 2020, among others, 10 new articles and 6 new digitalized books, and one thesis have been uploaded to our website, which is the most significant electronic repertory of Hungarian pharmacy history books, articles, photos and other pieces of information.

At the end of 2020, on 22 December, we have launched a new service on our website named “COVID-19”, which is linked to an open Facebook page named “Coronavirus vaccination – literature review group” (in Hungarian Koronavírus vakcináció – szakirodalmi tallózó), with almost 21,000 members, laymen, and professionals (MDs, pharmacists, nurses, etc). In the frame of this service, we provide up-dated information on the Summaries of Product Information (SmPCs) of vaccines against COVID-19, a collection of “Readers’ questions and answers”, “Vaccination news” and “Clinical trial abstracts”. This is partly to serve the Hungarian population during these unusual times, document the current events as future history and lastly, popularise the whole website.

Because of the Covid pandemic, the traditional activities of our Society were reduced significantly during the year 2020. The most important programme of the year, the 16th Hungarian Pharmaceutical Congress (Congressus Pharmaceuticus Hungaricus) of the Hungarian Society for Pharmaceutical Sciences, originally scheduled for April 2020, was held on September 10-12th and organized as an on-line congress.

The programme of the biggest scientific meeting of Hungarian pharmacists included a section of oral presentations in the field of the history of pharmacy. In this section, eight lectures were presented, which covered a wide range of historical topics in pharmacy, including the history of the pharmaceutical industry, wholesaling, museology, church pharmacy, medicines packaging, etc. Their abstracts were published in the congress abstract book issued as a special number of scientific journal Acta Pharmaceutica Hungarica (<https://www.aph-hsps.hu/acta/index.php/aph/issue/view/6>). Another traditional meeting of our Society, the 55th Mátyás Rozsnyay Memorial Contest for a young pharmacist was also held on-line on September 26. The Pharmacy History Division participated in the work of the Evaluation Board. In the programme was presented one lecture (author: Boglárka Tenke) related to pharmacy history, dedicated to the life and work of a famous Hungarian pharmacist and viticulturist, Zsigmond Katona.

ITALY – ACCADEMIA ITALIANA DI STORIA DELLA FARMACIA

Because of the Covid-19 pandemic, the 70th National Congress of the AISF took place online between 28-29 November 2020 with the support of the University of Ferrara. Many relations about the recent historical and pharmaceutical studies were presented, and as usual, they will be published in our review *Atti e Memorie*. Fortunately, we didn't have deceased colleagues, and in 2021 we hope to organize the 71st National Congress regularly in the summer, or online in case of Covid-19 pandemic restrictions. In 2021 will also take place the election of the new council of AISF. The AISF is working to organize the International Congress of History of Pharmacy in Milan in early September 2022 by the old and prestigious hospital Ca' Granda (now University of Milan), founded in 1456 by the Duke of Milan Francesco Sforza and designed by the architect Filarete. The main theme of the international congress will be "Health and Well-being". The most important target of WHO is "reaching of the highest level of health", defined as "a state of total physical, mental and social well-being", and not simply the lack of sickness and infirmity. For this reason, the topic of the congress takes his starting point in the "Prospectus Pharmaceuticus sub quo Antidotarium Mediolanense" of 1668, almost certainly the first official pharmacopeia in the world that have a specific chapter dedicated to the manufacture of beauty products, so to make them similar to the medicaments. The AISF, through its President, will communicate the final title of the congress.



Japanese Society for the History of Pharmacy (JSHP) is deeply saddened by the passing of Dr. Koji Yamakawa on December 29, 2019, at the age of 91. During his lifetime, Dr. Yamakawa taught at the Faculty of Pharmaceutical Sciences, Tokyo University of Science, and served as the 5th president of JSHP (2005-2011). Professor Yamakawa made numerous outstanding contributions in a variety of fields ranging from his publications on organic chemicals to those on the history of Japanese and international pharmacy. Perhaps his greatest contribution to JSHP was the editing of the first comprehensive history of the Japanese pharmaceutical industry in 1995. Twenty-six books from his personal collection were donated to the History of Pharmacy Library of the Graduate School of Pharmaceutical Sciences at the University of Tokyo by his daughter, Hiromi.

Appointment of a new JSHP President

At the General Assembly Meeting held online in April 2020, Dr. Kazushige Morimoto was appointed as the 8th president of JSHP for a term of two years. Dr. Morimoto is currently a guest scientist at the National Institute of Health Sciences. He holds a doctorate in Pharmaceutical Science, is a certified Education System-qualified Pharmacist, and earned a second doctorate in Ministry. He has extensive work experience at the Ministry of Health, Labour, and Welfare, the World Health Organization, HTP/EDM, and PMDA (Pharmaceuticals and Medical Devices Agency). As the new president, Dr. Morimoto's aspirations are to make JSHP a more attractive society where mid-career specialists, especially women, can play an active role, to raise the status of the Japanese Journal for the History of Pharmacy (Yakushigaku Zasshi), to strengthen cooperation with ISHP, and to work on the creation of a business plan to commemorate the 70th anniversary of the founding of JSHP in 2024. Under the leadership of the new president, JSHP is expected to develop in various fields.

Meetings

The General Assembly Meeting of JSHP was held online on April 24, 2020. This year, however, because of the spread of COVID-19, two special lectures, which are held annually on the same day as the general assembly meeting, were canceled. The 2020 Shibata Forum (summer), the Annual Meeting (fall), and the Six Societies Meeting of the Histories of Medicine, Pharmacy, Dentistry, Veterinary Science, Nursing, and Western Learning (December) were also rescheduled for next year due to the spread of the COVID-19.

General circumstances caused by COVID-19 responses by JSHP

In Japan, particularly since November 2020, the number of persons testing positive for COVID-19 has increased sharply. The third wave of infection is underway, which is having a great impact on many types of social activities. In order to prevent the further spread of the virus, Japanese health authorities are urging residents nationwide to avoid close contact. In response, academic societies such as JSHP must also adapt to the changing situation. In addition to canceling and rescheduling various academic gatherings this year, the Board of Directors and Councilors' meetings will be held online in 2021.

International Exchange

JSHP accepted the kind invitation by AIHP to attend the History of Pharmacy Festival held on 24-29 September. Those who took part in the festival found it most informative and look forward to future opportunities.

JSHP published volume 55 numbers 1 and 2 of the Japanese Journal for the History of Pharmacy (Yakushigaku Zasshi) and the History of Pharmacy Newsletter (Yakushi Letter), numbers 83, 84, and 85.

Main activities

The Lithuanian parliament (Seimas) declared 2020 as the year of the doctor of biological sciences, pharmacist and herbalist Eugenija Šimkūnaitė (1920-1996). Šimkūnaitė dedicated her life to the study of medicinal plants and folk medicine.

Many events were organized to commemorate Šimkūnaitė's life. In June, an exhibition of Lithuanian folk medicine was opened in the yard of the Museum of the History of Lithuanian Medicine and Pharmacy in Kaunas.

The Museum of the History of Lithuanian Medicine and Pharmacy produced a virtual exhibition Prescriptions and their place in pharmacy history (Curator: Zenona Šimaitienė). The museum's collection contains more than 700 prescriptions from the middle of the 19th century to the end of the 20th century.



An international e-conference "Contemporary pharmacy: issues, challenges, and expectations" was organized by the Faculty of Pharmacy of the Lithuanian University of Health Sciences (LUHS). 


Students during the lectures on the Development of Pharmacy: 2018 and 2020.

NFHS Meetings in 2020

The Covid-19 pandemic resulted in more or less a lockdown in Norway from March 12. This affected the possibilities of conducting meetings the traditional way.

The Annual Meeting in NFHS 2020: As a result of the Covid-19 pandemic restrictions, the meeting was conducted electronically. 21 members voted by e-mail. All documents relating to the validity of the meeting were approved. The Annual Report for 2019, the financial report for NFHS, as well as the one for the journal *Cygnus*, and the budget proposal for 2020 were all approved. The members also supported the proposals for membership fee for 2021 and a small change in the statutes pertaining to the number of Board members. The recommendation from the nomination committee for the incoming Board was unanimously approved. The elected Board: Liv Slettevold (chair), Erik Andrew (second chair), Holger Moe Tørisen (secretary), Sissel Brinchmann, and Anne Gerd Granås.

The Autumn Member Meeting in November: Again, the Covid-19 restrictions forced us to arrange the meeting as a webinar on November 4. This turned out to be very successful with more participants than we normally would have, with everyone watching and listening in their homes. The program opened with an exciting and dramatic tale by retired professor Jens Kristian Wold when he was a young military pharmacist during the Suez conflict in 1956-57.

Other topics were: Trygve Fjeldstad gave us the history of The Norwegian Medicines Manual for Health Personnel. Øyvind Holte looked at the history of The Pharmacists Sports Association and its cabin in the forest outside Oslo (Farmasøythytta). Erik Andrew focused on the pharmacist and chemist Hans H Hvolslef, while Liv Slettevold, who in 1998 established a strongly needed educational program for Regulatory Affairs, described the running of these courses up to 2003. Grethe Eide gave us an interesting look into a Pharmaceutical Study Group on Lifelong Learning. Gunnar Fossaa gave an interesting insight into the old pharmacy at the museum “Glomdalsmuseet”, as well as a “tour” of the collections. Professor Anne Gerd Granås shared the experience from the first-year student project “My Pharmacy History”, a series of interviews with seasoned pharmacists and their lives in different areas of our profession.

Publications

The Norwegian Society for the History of Pharmacy published the membership journal *Cygnus* in February 2020. (It was first published in October 1997, and has since been published once or twice a year). The latest issue of *Cygnus* is now being distributed to the NFHS members. Through 2020 NFHS published four digital newsletters to the members.

Lectures

NFHS has given lectures on the topic of the history of pharmacy at the University of Oslo, Department of Pharmacy.



POLAND – HISTORY OF PHARMACY DIVISION OF POLISH PHARMACEUTICAL SOCIETY

Polish pharmacists working in the profession include about 150 persons who show an active interest in the history of pharmacy. The year 2020 was unfavorable for direct contacts; nevertheless, the activity continued, as follows:

On 20 January 2020, Gdańsk held celebrations for the 90th birth anniversary of Dr. Sc. Aleksander Drygas. The scholar hosted a visit of historians of pharmacy from across Poland. A formal address was held by Lidia Maria Czyż, Ph.D., chairwoman of NCHP. On 20 February, the Szczecin chapter held a celebration honoring an unusual achievement, 60 years of professional work of MSc. T. Kończak Zielińska. On 24 February, the Kraków chapter organized a scientific session for the 100th birth anniversary of colonel Jerzy Pertkiewicz, Ph.D. These events took place before the restrictions imposed due to the pandemic, and they provided an opportunity for face-to-face meetings and discussions.

The most significant scientific conference of 2020 was prepared by A. and L. Birkenmajer Institute for the History of Science, Polish Academy of Science, as well as Societas Scientiarum Klukoviana et Jablonovianae Museum of Agriculture in Ciechanowiec and was entitled “International Scientific Conference for Innovation in Agriculture: Tradition and Contemporary Times. In memory of Duchess Anna Jabłonowska, née Sapieha”. It was held on 18-19 September via remote means of communication. Over 20 participants made their presentations and the event was observed by nearly 100 people; both groups included members of the NCHP.

Another nationwide scientific conference was the 4th symposium organized on the occasion of Sts. Cosmas and Damian Day by the Museum of Biecz Region on 19-20 September in Biecz. This time the title was “Botanical and sensory gardens in Poland and Europe”.

Members of the Kraków chapter took part in the Conference entitled “Pharmaceutical raw materials”, organized by the chapter in Bydgoszcz, on 15-16 October. Historians from the Szczecin chapter also actively participated in the symposium. On 25 September the Łódź chapter organized a webinar on “Chemists from Łódź in Polish-Soviet war”.

Members of the NCHP, despite all the restrictions, continued their work. In Warsaw, they cooperated with the Museum of the History of Medicine at the Medical University of Warsaw. Maria Pajak, MSc., (Opole) initiated cooperation with the Museum of the Opole University, Museum of Opole Silesia, and the National Archive in Opole. Katarzyna Hanisz, PhD., joined the Academic Council of J. Muszyński Museum of Pharmacy.

In 2020 distinctions in recognition for their work were awarded to:

- Dr. Jan Majewski personality of two decades “Pharmacist who contributed to the image of Polish pharmacy”.
- Dr. Jerzy Waliszewski (Stargard) received the title of voluntary custodian of historical monuments.
- Dr. Majewski received the Medal “True to tradition” on the 30th anniversary of the Society for Commemoration of Wielkopolska Uprising, and acknowledgment for his support for the initiative “renovation of the family grave of Prof. Jan Czochralski, pioneer of electronics and crystallography” from the Commune Office in Kcynia.

Historians of pharmacy in Warsaw regularly visit cemeteries in Warsaw where they put flowers at the monuments commemorating chemists and pharmacists; in 2020 they visited Protestant cemeteries.

Throughout 2020 a number of works related to the history of pharmacy were published in books and journals dedicated to the pharmacy, medicine, and library studies.

Unfortunately, the Symposium for the History of Pharmacy did not take place as planned, it was postponed to be held at a more convenient time.

In 2020, the members of the Section were active. Although in difficult conditions, quantitatively speaking, their activity was considerably reduced, but in terms of publications, this year they presented their results in two scientific papers in international journals with undiminished energy and efforts.

The main activities and news related to the Sociedad de Docentes Universitarios de Historia de la Farmacia de España (SDUHFE) have been disseminated through our website (<https://sduhfe.wordpress.com>) and its corresponding associated Facebook page (<https://www.facebook.com/SDUHFE>). This information can be followed through the subscription service we offer, both on the website and on the Facebook page, or by visiting the "We are News" section (<https://sduhfe.wordpress.com/category/somos-noticia>), where most of the content published throughout 2020 has been included. Below, in chronological order, we offer an extract of this news:

15 January 2020: Antonio González Bueno and Cecilio J. Venegas Fito, academics from the Real Academia Nacional de Farmacia (Instituto de España). We would like to congratulate our colleagues, Antonio González Bueno, and Cecilio J. Venegas Fito, on their recent appointments as Full and Corresponding Academy Members, respectively. Cecilio took office on 13 February 2020, at 19:00, with a speech entitled "El No-Do como instrumento documental de la Historia de la Farmacia en España". We do not yet know the date on which Antonio will read his reception speech, which has been postponed due to the COVID crisis.

18 March 2020: Postponement of the 6th Conference of our Society. The exceptional circumstances oblige us to put off the 6th Conference of our Society, to be held in Calamocha (Teruel), until the optimum epidemiological conditions have been met.

3 April 2020: The annual ISHP Newsletter (2020) is published. The International Society for the History of Pharmacy (ISHP), to which our Society belongs, has published the Newsletter for 2020, which includes the activities carried out by the Society of University Lecturers in the History of Pharmacy.

21 April 2020: "Conocer el pasado es predecir el futuro". Our Society has just joined the initiative "Knowing the past is predicting the future", a platform created by people and societies from the History of Medicine and Health Sciences. Our colleague Enrique Aramburu, one of the initiators of this platform, will be our representative in this project. Its objectives, as set out in the founding manifesto, are as follows "To establish in each state of the European Union, a permanent research group on the origin, development, termination, and consequences of what have been epidemics and pandemics throughout history. To integrate into all the epidemiology teams of the State and the Autonomous Communities, health science historians specialized in studies on the history of diseases and historical demography. Introduce a chapter of historical epidemiology in the subject of the history of medicine in the curricula of all the Faculties of Medicine and Health Sciences".

1 May 2020: Death of Iris-Abril Figuerola i Pujol, in March 2020. Iris was Professor of the History of Pharmacy at the Chair of History of Pharmacy and Pharmaceutical Legislation of the Faculty of Pharmacy of the University of Barcelona until her retirement.

4 September 2020: We leave you with information about the Social History of Pharmacy and Pharmaceuticals Festival, a virtual event organized by the American Institute of the History of Pharmacy (USA).

29 September 2020: Recognition by the American Institute of the History of Pharmacy for our colleague Antonio Ramos Carrillo. Our colleague Antonio Ramos Carrillo has obtained the "AIHP Certificate of Commendation", a distinction awarded by the American Institute of the History of Pharmacy, for the creation and management of the Museo de Historia de la Farmacia de Sevilla, as well as for his work in collecting, researching and teaching in this Museum. El Museo de Historia de la Farmacia de Sevilla provides an overview of the professional and scientific activity of pharmacists in the 19th and early 20th centuries, at a time when the industrial revolution was modifying, as in so many other disciplines, the aesthetics, and dynamics of the pharmaceutical world. In this way, it constitutes a collection of pharmaceutical tools aimed at achieving the well-being of the individual and fighting disease. The material ranges from the preparation, conservation, and dispensing of the medicine itself, to tools for analysis, a collection of simple vegetables, and pharmaceutical specialties.

1 December 2020: "Plantas y medicamentos: una apasionante visión histórica". Our colleagues from the Seville Pharmacy History Museum, led by Antonio Ramos Carrillo, presented us with an entertaining and instructive video entitled "Plants and medicines: an exciting historical vision" (<https://youtu.be/msf6rDMEsFU>), which was presented at the "Researchers' Night".

14 December 2020: Newsletter number 1 of the Museo de la Farmacia Hispana. The Museo de la Farmacia Hispana (Faculty of Pharmacy. Universidad Complutense de Madrid. <https://www.ucm.es/museofarmaciahispana>) has just published the first issue of its Newsletter: "Our intention is to publicize all the Museum's activity to our followers and to communicate future projects with the aim of sharing and making you participants in our work of documentation, conservation, research and dissemination of the pharmaceutical heritage that we preserve".

In February 2020, our newsletter, Novellas, was published full of memories of events in 2019 (Washington, D.C., and the excursion to Val-de-Travers); the Corona pandemic did not feature in it! From mid-March, however, Switzerland was already in lockdown, the home office was the order of the day, and "stay at home" was the slogan; everything else is sufficiently well known. The Summer Novellas consisted of some contributions to the ongoing Corona situation.

The planned scientific conference in the monastery of Muri on the topic of "Forgeries in the History of Pharmacy" in May had to be canceled, the attempt to organize a general meeting in Diessenhofen in autumn failed, as only four members had registered for it due to the unclear hazard of the situation. In the end, the Board had no choice but to call a meeting by correspondence, which was successfully held on 3 December. The 40 people who attended accepted the 2019 accounts, thanked the treasurer for his work, and discharged the Board. With the election of Dr. Sara Ruppen, we can welcome a new Board member. Rosmarie Schürch, member of the Board for many years, stepped down at the General Assembly. We would like to take this opportunity to thank her for the interesting events that have taken us to different parts of Switzerland.

The commemorative publication for the 70th birthday of Professor François Ledermann "Scientia non unius populi sed orbis terrarum / Zur Vielsprachigkeit in der Pharmaziegeschichte" was published as the 32nd volume in the Grüne Reihe. The volume was edited by Sabine Anagnostou, Ursula Hirter-Trüb and Claudia Zerobin Kleist. At this point we would like to thank the DGGP e.V. for the constantly good cooperation.

The Board has designed a new promotional flyer for the Society, which has not yet been distributed, due to a lack of opportunity caused by the Corona pandemic. During the summer, the texts of our website www.histpharm.ch were revised, and new pictures will follow in 2021. And finally, we still have the goal of translating the entire website into French.

Notre première lettre d'information de l'année, les « Novellas », a été publiée en février 2020. Elle était pleine de souvenirs de 2019, notamment celui de Washington, D.C., et de notre rendez-vous dans le Val-de-Travers mais la pandémie de Coronavirus n'était pas évoquée ! Dès la mi-mars, la Suisse fut pourtant plongée en quarantaine, télétravail et confinement à la maison étant devenus les règles du quotidien. La suite est connue de tous, mais les « Novellas » de l'été sont revenues sur les conséquences de cette pandémie.

La conférence scientifique prévue en mai 2020 au monastère de Muri sur le thème "Les faux dans l'histoire de la pharmacie" a dû être annulée. De la même manière, notre assemblée générale à Diessenhofen en automne a également été annulée, car seuls quatre membres s'y étaient inscrits en raison des risques de contamination. Le conseil s'est finalement résolu à organiser une assemblée virtuelle qui s'est tenue le 3 décembre sur la base des votes écrits préalablement transmis par 40 participants. Ces derniers ont accepté les comptes 2019, remercié le trésorier pour son travail et donné décharge au conseil. Avec l'élection du Dr. Sara Ruppen, nous avons ainsi accueilli un nouveau membre au sein du conseil. Elle remplace Rosmarie Schürch, qui s'est retirée cette année de ce conseil auquel elle participait depuis de nombreuses années. Nous tenons à la remercier vivement pour sa collaboration active qui nous a notamment permis de découvrir de nombreuses régions de notre pays.

Notre collection « La Série verte » s'est étoffée avec un 32ième volume reposant sur le colloque organisé pour le 70ième anniversaire du professeur François Ledermann "Scientia non unius populi sed orbis terrarum / Le multilinguisme en Histoire de la Pharmacie". Il a été préparé par Sabine Anagnostou, Ursula Hirter-Trüb et Claudia Zerobin Kleist. Nous tenons à ce propos à remercier la Société allemande pour l'Histoire de la Pharmacie pour son excellente et toujours renouvelée coopération.

Le conseil a enfin conçu un nouveau dépliant publicitaire présentant notre société. Il n'a pu encore être distribué en raison de la pandémie actuelle. Notre site web www.histpharm.ch a également été revu cet été au niveau de sa rédaction. De nouvelles illustrations suivront en 2021. Il ne nous restera plus ensuite qu'à le traduire en français.

Im Februar 2020 wurde unser Mitteilungsorgan, die "Novellas", voller Erinnerungen an Anlässe von 2019 (Washington, D.C., und den Ausflug ins Val-de-Travers) publiziert, die Corona-Pandemie kam darin nicht vor! Ab Mitte März war die Schweiz aber bereits im Lockdown, Homeoffice war angesagt und «bleiben Sie zu Hause» die Lösung; alles weitere ist hinlänglich bekannt. Die Sommer-Novellas haben dann einige Beiträge zur Corona-Situation gebracht.

Die geplante wissenschaftliche Tagung im Kloster Muri zum Thema «Fälschungen in der Pharmaziegeschichte» im Mai musste abgesagt werden, der Versuch im Herbst eine Generalversammlung in Diessenhofen zu organisieren, schlug fehl, da sich auf Grund der Gefährdungslage nur vier Mitglieder dafür angemeldet hatten. Dem Vorstand blieb schliesslich nichts anderes übrig als eine schriftliche Versammlung anzuberaumen, welche am 3. Dezember erfolgreich durchgeführt werden konnte. Die 40 teilnehmenden Personen akzeptierten die Rechnung 2019, dankten dem Kassier für seine Arbeit und erteilten dem Vorstand die Décharge. Mit der Wahl von Dr. Sara Ruppen dürfen wir ein neues Vorstandsmitglied begrüssen. Auf die Generalversammlung ist das langjährige Vorstandsmitglied Rosmarie Schürch zurückgetreten. Wir möchten ihr bei dieser Gelegenheit herzlich für die interessanten Anlässe danken, die uns in verschiedene Teile der Schweiz geführt haben.

In der «Grünen Reihe» erschien die Festpublikation zum 70. In common with societies everywhere, the BSHP has had to adjust to the restrictions imposed by the Covid-19 pandemic. We were able to hold only a single in-person meeting in 2020; Dr. Emma Spary, Reader in the History of Modern European Knowledge, Corpus Christi College, Cambridge spoke to us concerning “Suppliers of plant drugs in late seventeenth-century Paris: in (and out?) of the pharmacy” at the UCL School of Pharmacy.

The Annual Conference, due to be held at the end of March 2020 in Manchester had to be postponed due to national lockdown. Provisional plans for it to be carried out in March 2021 have also had to be revised. It will now be delivered freely available and online (registration required) from Friday 26 to Sunday 28 March inclusive. Further details can be found on the BSHP website (see link below).

We normally hold our AGM at the Annual Conference. This year it took place in October and involved the usual confirmation of changes to Office-bearing personnel.

The 2020 Burnby Memorial Bursary was awarded to Dr. Sebastian Kroupa, University of Cambridge, for his paper: "Medical knowledge in transit between Manila and London: Philippine Materia Medica – Lost and found in translation." This year's winner of the Annual Pharmacy History Research Grant was Soh Xi Ken of the University of Sunderland, School of Pharmacy, for his project "A holistic view on the evolution of pharmacy education from the 19th to 21st century: a case study on University of Sunderland's School of Pharmacy". We look forward to both of these winners being able to present the results of their studies to the Society in due course.

Four issues of the *Pharmaceutical Historian: An International Journal for the History of Pharmacy* (vol. 50, nos. 1,2,3,4) were published during the year in March, June, September, and December (and accessible via Ingenta) under the editorial oversight of Stuart Anderson. The December issue also contained some online-only content. Stuart also produced a five-year index for 2016–2020 (volumes 46–50), which is available at the BSHP website.

Having investigated the potential of the Zoom platform for delivery of a revised program of BSHP events, we held our first meeting on 11 January. This took the form of a Panel Discussion on the topic What is the future for pharmacy history?, hosted by Professor Mark Nesbitt of the Royal Botanic Gardens at Kew. Participants in the discussion were Independent Curator and pharmacy historian Briony Hudson, Anna Greenwood (Nottingham University), and Yewande Okuleye (Leicester University). The number of registrants for the meeting exceeded our wildest dreams and have stimulated planning of an ambitious program of events for 2021.

USA – AMERICAN INSTITUTE OF THE HISTORY OF PHARMACY

Main Activities

The American Institute of the History of Pharmacy (AIHP) hosted the New Social History of Pharmacy and Pharmaceuticals Festival in September. The Festival was a five-day free online streaming event that brought together scholars and researchers from around the world to explore perspectives on the social history of pharmacy and pharmaceuticals. The Festival's 21 events, including contributed paper panels and lectures, drew a total of 1,150 participants from 29 different countries across six continents.

In May and June, AIHP and the University of Wisconsin-Madison School of Pharmacy sponsored the inaugural Edward Kremers Seminar in the History of Pharmacy & Drugs, a series of five online weekly lectures on topics related to the history of pharmacy and pharmaceuticals. The series drew approximately 80 participants for each lecture.

In April 2020, the Institute launched the AIHP COVID-19 Historical Documentation Project, which seeks to document pharmacy stories and experiences during the COVID-19 global pandemic for the benefit of future historians and scholars. The Institute hopes to preserve the history of the effects of this public health emergency on all types of pharmacy experiences. In 2020, AIHP's awards program honored several individuals and organizations for their contributions to the field of the history of pharmacy and pharmaceuticals. The 2020 AIHP Robert P. Fischelis Award was awarded to Robert Buerki, Ph.D., RPh, for his extraordinary contributions to the Institute and the field of pharmacy history. Dr. Buerki, Professor Emeritus at The Ohio State University College of Pharmacy, is a member of the International Academy of the History of Pharmacy. Another member of the International Academy, Professor Michael Flannery, was awarded the 2020 AIHP Glenn Sonnedecker Prize for his article, "Government as Apothecary: Civil War Pharmacy and the Common Good." The Institute awarded five Certificates of Commendation to recognize meritorious contributions to the history of pharmacy and pharmaceuticals. International honorees included Professor Antonio Ramos Carrillo, Ph.D. (University of Seville (Spain)) for his work as the founder and current Director of the Museum of the History of Pharmacy of Seville, and Professor Paloma Ruiz Vega, Ph.D. (University of Cadiz (Spain)) for her work as the founder and president of the pharmacy section of the Ateneo [Athenæum] de Cadiz, where over the past ten years she has organized and presented almost 100 lectures and discussion on historical and cultural aspects of pharmacy.

AIHP awarded two Ph.D. Thesis Support Grants in 2020, each for \$2,000. Barbara Di Gennaro, a doctoral candidate in the Department of History at Yale University, was awarded a grant to conduct research related to her dissertation, tentatively entitled “The State Drug: The Politics of Theriac in Early Modern Italy.” Jacob Green, a doctoral candidate in the Department of History at UCLA, was awarded a grant to support work on this dissertation currently entitled “Recreation, Mysticism, and Anesthesia in the 19th Century.”

Important News

AIHP in September announced significant changes coming to its academic journal, *Pharmacy in History*, in 2021. The Institute entered into a new partnership agreement with the University of Wisconsin Press for the publication of the journal. In conjunction with the move to the UW Press, AIHP will change the name of the journal to *History of Pharmacy and Pharmaceuticals* (HoPP) to better reflect its broad topical scope.

The Institute undertook a comprehensive review of its awards program during 2020. The review produced a series of recommendations, approved in June by the Institute’s Board of Directors, that will change protocols for awarding the George Urdang Medal, the Edward Kremers Award, and the AIHP Glenn Sonnedecker Prize. The changes, which take effect in 2021, are intended to enhance the prestige of the awards and better advance the mission of the Institute.

In 2020, AIHP received a grant to expand its Pharmaceutical Trade Catalog Collection, a rare and unique collection of more than 400 historical pharmaceutical trade catalogs published between 1829 and the 2000s. The Institute also entered into an agreement with the University of Wisconsin Digital Collections Center (UWDCC) to digitize parts of the Trade Catalog Collection and the AIHP Drug Topics Photograph Collection, a collection of approximately 17,000 pharmacy-related photographs. The project, to be implemented over the next several years, marks the Institute’s first major step toward digitizing its historical collection.

The American Pharmacists Association (APhA) in 2020 awarded the Remington Honor Medal, the U.S. pharmacy profession’s highest recognition, to AIHP Vice President John Grabenstein, Ph.D., a globally recognized vaccinologist, pharmacist, and epidemiologist. Dr. Grabenstein was also the featured speaker at AIHP’s Annual Business Meeting in November, where he delivered a lecture entitled “Applying History’s Lessons to Contemporary COVID-19 Vaccination.” Dr. Grabenstein is slated to become AIHP’s President in November 2021.

In 2020, the American Pharmacists Association (APhA) also announced that Gregory Higby, Ph.D., AIHP’s former Executive Director and currently AIHP’s Fischelis Scholar, had been selected to serve as the 2021 Honorary President of APhA.

Obituaries

Louis Vottero, who served as AIHP's Treasurer for more than 30 years, died on September 12, 2020. He was 87. Professor Vottero served on the faculty of the College of Pharmacy at Ohio Northern University, in Ada, Ohio, for many years. While serving as the Institute's Treasurer, Professor Vottero was instrumental in AIHP's receipt of a \$1.2 million bequest in 1983 from the estate of Robert Fischelis, a leader of the U.S. pharmacy profession. The bequest remains the single largest financial contribution the Institute has ever received.

CALL FOR NOMINATIONS FOR THE GEORGE URDANG MEDAL

The American Institute for the History of Pharmacy is now accepting nominations for the George Urdang Medal. The deadline for receipt of nominations is June 1, 2021.

The George Urdang Medal recognizes the lifetime achievements of a person who, over a sustained period, has made important scholarly contributions to the field of the history of pharmacy and pharmaceuticals. The George Urdang Medal is awarded without regard to citizenship or nationality.

The award honors Professor George Urdang (1882-1960), a pioneering historian of pharmacy in Germany and the United States, the founding Director of AIHP, and the founder of the first American graduate program in the history of pharmacy.

A panel of historians will evaluate nominations on the basis of the nature and significance of the nominee's scholarly contributions to the field of the history of pharmacy and pharmaceuticals, and the span of time over which those contributions were made. Contributions to the field may include (without limitation) scholarly publications, exceptional service to professional organizations, dedicated work for scholarly or popular publications, outstanding contributions to education, and/or significant achievements in the collection and preservation of historical sources or collections.

Nominations for the George Urdang Medal must include at least one letter of nomination outlining the nominee's scholarly contributions to the field. Nominations must also include the nominee's curriculum vitae (or similar biographical information) and any documents or other supporting materials for the panel to consider. Please email nominations to aihp@aihp.org.

AIHP expects to announce the recipient of the 2021 George Urdang Medal in the fall. Further information about the George Urdang Medal is available on AIHP's website.

AAIHP originally established the George Urdang Medal in 1952. Prior to this year's competition, the Urdang Medal recognized a scholarly publication in the field of pharmacy history that exhibited superior quality and distinctive significance.

A 2020 task force, headed by Historical Director Lucas Richert, Ph.D., recommended changes to several Institute awards, including the George Urdang Medal and the Edward Kremers Award. The task force decided that the two awards had largely overlapping purposes and recommended using the Urdang Medal to recognize lifetime achievements in the field of pharmacy history. The Edward Kremers Award will now recognize the author(s) of a single outstanding scholarly publication in the field of pharmacy history.

The task force also recommended conferring both awards without regard for citizenship or nationality and conducting competitions for the two awards in staggered years. A competition for the Edward Kremers Award will be conducted in 2022. AIHP's Board of Directors approved revised protocols for the awards reflecting the task force's recommendations.
